Notice Concerning Change to Auditors of the Investment Management Company

TOKYU REIT, Inc. ("TOKYU REIT") today announced that the Board of Directors of its investment management company, Tokyu Real Estate Investment Management Inc. ("Tokyu REIM"), held a meeting on June 5, 2008, and resolved to propose a change of auditors at the Annual General Meeting of Shareholders to be held on June 20, 2008. Details are as follows.

2. Retiring Auditor

Subject to approval at its Annual General Meeting of Shareholders, Tokyu REIM shall report details of change to auditors to the Commissioner of the Financial Services Agency in accordance with rules and regulations relating to the Financial Instruments and Exchange Law. In addition, Tokyu REIM shall report details of the aforementioned changes to the Minister of Land, Infrastructure and Transport in Japan pursuant to regulations relating to registration as a real estate investment advisory company and to a requirement of acquired discretionary transaction agent approval. In accordance with the Building Lots and Buildings Transaction Business Law, details of changes shall also be reported to the Governor of Tokyo.
