Notice Concerning Change to Director, Amendments to the Articles of Incorporation and Changes to Officers of the Investment Management Company

TOKYU REIT, Inc. ("TOKYU REIT") today announced details of a decision by our investment management company, Tokyu Real Estate Investment Management Inc. ("Tokyu REIM"). The decision was made at their Board of Directors meeting held today and Tokyu REIM passed a resolution to submit a proposal to their shareholders concerning election of a director and a amendments to the Articles of Incorporation to be made as of March 9, 2015 as agendas of the shareholders' meeting, pursuant to Article 300 and Article 319, Paragraph 1 of Japan's Corporation Law. Details are as follows.

The proposed candidate for appointment as Director is scheduled to resign from the post as Auditor of Tokyu REIM, his current position, as of March 9, 2015. After being elected as the Director, he is scheduled to be nominated as a candidate for Representative Director and Executive Vice President at the Board of Directors meeting planned to be held on the same date. In accordance with this, changes to officers are also scheduled to be submitted.
